

## ***Berkeley Studies* Style Guide for Submissions**

- *Berkeley Studies* accepts scholarly articles in American or British English, using American punctuation. Submitted articles must be suitable for blind review and should be submitted to the Senior Editor.
- *Berkeley Studies* accepts notes, reviews and abstracts in American or British English, using American punctuation, submitted to the appropriate editor.
- Authors must submit an abstract along with their submission not to exceed one-hundred (100) words.
- Contributors should use Issue #25 (2014) as a model for formatting.
- Submissions should be in Word format suitable for conversion to PDF for publication.
- Follow American-style punctuation. In particular, use double quotes, placing commas and periods inside the quote marks (“these,” and “those.”) but colons and semicolons outside the marks (“these”: and “those”;).
- Reserve single quotes for quotations inside of quotations. Use double quotes to highlight concepts and words.
- Use square brackets for author interpolations: “The having of general ideas, says he [Locke], is that which puts a perfect distinction *betwixt man and brutes* [emphasis mine].”
- Follow the Chicago Manual of Style (15th edition) for citations in submitted material.
- References should be included in footnotes (not in a bibliography) using the following format:

- Provide specific page numbers for secondary sources. After the first full reference, use abbreviated references—such as W 2: 248-49; or Tipton, “Berkeley’s Imagination,” 86.
- Use the following [abbreviations and short titles](#) of the principal works by Berkeley in references or (preferably) in the running text:

*Alc* George Berkeley, *Alciphron, or the Minute Philosopher* (1732), in W, vol. 3. Cited by dialogue number, section, and page.

*Analyst* George Berkeley, *The Analyst* (1734), in W, vol. 4. Cited by section or query number.

CSM René Descartes, *The Philosophical Writings of Descartes*. 3 vols. Ed. and trans. John Cottingham, Robert Stoothoff, and Dugald Murdoch, and (vol. 3) Anthony Kenny. Cambridge: Cambridge University Press, 1984-85, 1991. Cited by volume and page.

DHP George Berkeley, *Three Dialogues between Hylas and Philonous* (1713), as found in W, vol. 2. Cited by page.
